## Who can take this course?

- 1. Current CSUF students who are graduating in Summer 2024 or earlier and have passed ACCT301A and ACCT301B with a "C" or higher, not currently receiving sponsorship of Becker's CPA Review from other parties.
- 2. CSUF Alumni who are not receiving sponsorship of Becker's CPA Review from other parties.

### What is the cost?

After sponsorship from the School of Accountancy, students will be responsible for paying a discounted fee of \$995.
